SCREEN DEALING COMMITTEE**

Members were advised in Circular No: 98/00 that amendments have been made to Trading Rules TR.2.6 and TR.2.6A, and that the Board has determined that the Screen Dealing Committee is now to be elected in accordance with the amended rules.

The Committee is to comprise 12 elected members, 10 being representatives of Full Members and 2 of Local Members. Separate elections are being held for each class.

Nominations are hereby called to fill the vacancies on the Committee for Full Member representatives. The representatives must, unless the outgoing Committee determines otherwise, be SYCOM Traders who have had at least two years continuous and recent experience trading futures and/or options, together with at least six months screen dealing experience.

**Nominations for candidates in the attached form should be lodged with the Secretary by 5.00 pm on Friday 30 June 2000.**

The current Committee, excluding the members of the SFE staff who are also members of the Committee, comprises:

The procedure for the election is:

1. Full Members may nominate more than one candidate, but only one candidate from each Full Member may be nominated;
2. each Full Member will receive one ballot paper for voting purposes;
3. where two or more Full Members are associated, they will be treated as a single group such that only one of the Members may vote and only one candidate from the group may be nominated;
4. the term of office of members of the Committee is to be two years, (except for persons filling a casual vacancy), so that in general half the Committee will retire in each year;
5. at this first election, the five candidates in respect of whom the greatest number of votes has been cast will be elected for two years and the five with the next greatest number will be elected for one year. At subsequent elections (subject to the appointment of any candidate to fill a casual vacancy) each Full Member representative will be elected for two years;

6. casual vacancies may be filled by the members of the existing Committee (with the approval of the Board) until the next election; and
7. persons who may vote on behalf of a Full Member are those who have already been approved for the purposes of voting at EGMs.

Following the receipt of nominations, ballot papers will be forwarded to all Full Members and must be returned to the Exchange by 5.00 pm on Friday, 14 July 2000.
