SFE & NZFOE DAYLIGHT SAVINGS CHANGE IN TRADING HOURS

Please be advised that New Zealand move to daylight savings time commencing Sunday 6th October 2002. This will create a three-hour difference between the NZFOE and SFE for a period of three weeks. Below is a table that outlines the change in Sydney time for all NZFOE contracts.

These contract trading hours in Sydney time are only applicable between 6th – 27th October

These hours apply to all NZFOE contracts until NSW moves to daylight savings on Sunday 27th October 2002. Once NSW move to daylight savings, all NZFOE contracts will revert back to their usual Sydney trading hours.

Monday 28th October 2002, all SFE contracts will change to their summer time trading hours, as the United States daylight savings time will finish on the 27th October. Below is a table that outline these new times.
