## **Greasy Wool Futures Contract February 1998 Expiry Information**

This circular sets out important information for the next contract expiry on Thursday, 19 February 1998, regarding:

- AWEX Appraisal deadlines
- Tender documentation

### **AWEX Appraisal Deadlines**

The attached AWEX bulletin sets out the AWEX Appraisal and Certification deadlines for the next contract expiry.

### **TENDER DOCUMENTATION**

This is a reminder that it is the Clearing Member's responsibility to obtain and provide SFECH with **original** copies of the following documentation. Tender documentation must be lodged on any business day within the delivery period prior to 12:30 pm, except on the final day of trading, when it must be lodged prior to 3:00 pm.

- IWTO Combined certificate - SFE Combination
- IWTO Combined staple certificate - SFE Combination
- Individual Test Certificates underlying Combination Certificates (refer to SFE Circular No. 286/97)
- IWTO Individual Certificate - single wool lot only
- IWTO Individual Staple Certificate - single wool lot only
- AWEX Appraisal Certificate
- SFE Warehouse Receipt

All the above documentation must be **original** copies. No faxed documentation will be accepted, and any Clearing Members attempting to submit copies other than the original documentation will be in

default.

All Clearing Members with short and/or long positions must lodge with SFECH an Ending Position Confirmation document everyday during the delivery period. The Ending Position Confirmation must be lodged with SFECH by 5:30pm every day during the delivery period except on the last business day when it must be lodged by 1:30pm. Clearing Members with short positions must also lodge a Tender Information Summary and Delivery Notification on the day that they require a delivery to take place. These forms must be lodged with SFECH by 12:30pm on any day during the delivery period except for the last business day, where they must be lodged by 3:00pm.

All wool must be held in a nominated warehouse and display samples must be ready for appraisal at the time the request is made.
